1. Introduction

Work Package 6 ("Capacity Building for National Focal Points") directly addresses the expertise and the skills (technical and soft) of the National Focal Points involved in the new EU4Health programme in its comprehensiveness. With a view to provide high-quality and impact services, it is expected that NFPs share general and specific knowledge of the programme and of other relevant initiatives. More in detail, WP6, focusing on the new areas and tools of the EU4Health programme and on synergies and opportunities within the context of other EU health-related instruments, has three main objectives:

- Enhancing and fostering the knowledge and the skills of the NFPs in the EU Member States and associated countries;
- Promoting the equality of opportunities for all EU Member States in accessing the EU4Health programme;
- Filling in the knowledge gap with respect to the transition from the old to the new programme, delivering a detailed training plan, addressing all NFPs.

In the framework of Task 6.1 "Training Programme for NFPS", the present Deliverable D6.2, "Training Plan" will therefore focus on the training addressed to EU4Health NFPs and include methodology, timing, tools, outputs and assessment actions.

2. Objective of the training

In the context of WP6, Task 6.1 is devoted to the creation and implementation of a training programme for NFPs. In particular, the purpose of this Task is creating and delivering a training programme for NFPs on both technical and soft skills. The specific topics addressed by the training programme are chosen taking into account inputs and needs expressed by NFPs. Topics can be eventually updated during the life-course of the Joint Action, according to necessities that may emerge. Among others, technical skills will be strengthened with relation to funding mechanisms, EU4Health topics, Horizon Europe actions and other related funding schemes (addressing programming, rules of participation synergies), while, the training programme on soft skills will include practical and innovative methods/tools to engage and support stakeholders, event organization and moderation, networking of stakeholders, project management and NFP team organization. The idea at the basis of the training activity is to promote a "training for trainers" activity in order to allow the eventual replication at the national level from Member States.

The training offered will foresee both sessions that will take place on-site and online. The on-site training consists of two general modules (both combining technical and soft skills) that will take place in maximum 5 itinerant editions. Each of these editions will bring together NFPs from 5/6 Member States and Associated countries, with the aim to allow team building, synergies and exchange of experiences.

The online training activity will be implemented through a maximum of 20 webinars on specific needs, expertise and technical knowledge, with the main focus being enhancing knowledge sharing, peer learning and capacity building.

3. Needs assessment and elaboration of data

In order to assess the needs of NFPs to better define and adapt the Training Programme, in occasion of the WP6 kick-off, held on the 22nd February 2022, the skeleton of the Training plan has been presented, collecting several inputs from NFPs.

In a second step, the Italian Ministry of Health and ProMIS created an online questionnaire with the aim to identify specific needs of the NFPs and to adapt and organize the activities of the Training Programme.

The questionnaire has been submitted to the NFPs, through a Google Forms survey, with the specific aim to understand the recipients' interest in receiving in-depth information on the EU4Health programme and other Horizon Europe actions.




Figure 1. Percentage of EU4Health NFPs among the respondents

Thirteen answers have been collected. The majority of the respondents were EU4Health NFPs, as the following pie chart (Figure 1) shows.





Figure 3. Respondents' interest in receiving in depth information on EU4Health specific issues

All topics proposed about the EU4Health programme attracted noticeable interest (with the majority of the answers being 4 (=very interested) out of 4 for 8 topics out of 9) and those related to improving and fostering health in the Union, to synergies and complementarities, to EU4Health 2022 (and beyond) Work Programmes have been the most voted ones, as it can be seen from Figure 2 and Figure 3.




Figure 5. Respondents' interest in receiving technical training on issues related to grants, operational budget and eligibility, selection and award criteria




Figure 6. Respondents' interest in receiving technical training on issues related to how to communicate EU4Health Programme, to funding and tenders portal and to project drafting





Figure 7. Respondents' interest in receiving technical training on Horizon Europe actions, direct funding schemes, indirect funds and programmes, cooperation and funds synergies

5. On-site Training

The on-site training activities will include a mix of technical and soft skills and will allow more interaction among participants, encouraging teambuilding, synergies and the exchange of experiences. Moreover, there will be the chance to proactively identify specific needs and doubts and to fill the eventual gaps. The 5 editions of each module will take place in different countries (see the subdivision below). The aim is to create itinerant on-site trainings, covering different geographical areas, giving priority to the newly nominated NFPs.

Module 1 of the on-site Training focuses on the EU4Health programme and on NFPs. It is conceived as preparatory for the second module.

The 5 editions of Module 1 will take place in Italy, Austria, Sweden, Czech Republic, Portugal. The following table summarises the structure and organisation of Module 1.

5.1 Countries participation

The onsite training activities is dedicated to the NFPs involved in the NFP4Health Joint Action (beneficiaries or affiliated entities) and eventual other stakeholders identified at National level, with a maximum of 5/6 participants per country. NFP (beneficiary or affiliated entity in this JA) has a dedicated budget of € 2000 (1 person per 2 modules). Expenses of eventual other participants involved will be borne by the sending organization. The mentioned budget decision has been made in accordance with the previous Agency CHAFEA during the drafting phase of the JA, in order to encourage EU4Health NFPs and related National authorities to invest in the training activities with a view to improve the performance of NFPs.

Each of the 5 editions of Module 1 and Module 2 will involve participants coming from up to 5 Countries. The subdivision presented below takes into account a geographical coverage as well as the level of experience of NFPs¹, in order to ensure a fruitful exchange (Deliverable 4.2 – Interim report on organizational models): a) Less than 1 year; b) 1-5 years; c) 6-10 years; d) More than 10 years.

¹ Deliverable 4.2 – Interim report on organizational models. "Five NFPs (in Italy, Belgium, Netherlands, Poland, Romania) reported their consolidated (more than 10 years) experience, which increased their capacity to design and create sustainable implementation actions. This experience is balanced by the less than one year of experience of other NFPs in Denmark, Ireland, Slovakia, Hungary, Germany, Iceland. The newly relocated Austrian NFP has less than one year experience, however the previous NFP had 1-5 years experience, at the time of transition." Slovenia is partner of the JA NFP4Health. However, it has not participated to the Survey made in the framework of WP4. Therefore, it is not included in the results of Deliverable 4.2 – Interim report on organizational models.
