VENICE CONFERENCE



On May 16–17, 2022, Executive Committee and External Advisory Board Meeting was held in Venice, Italy.

Participants in the two-day seminar gained knowledge about the Joint Action NFP4Health work packages' activities and outcomes. Participants had finally the opportunity to meet in person and share knowledge and experience as this was the Joint Action's first face-to-face gathering.



MAIN TOPIC AND THE OUTCOMES

During the meeting each work package described its state of the art and ongoing activities.

ProMIS, who is responsible for preparing the amendment documentation, presented the respective modifications, whose adoption has been implemented in the following weeks.

Parameters, that would need to be changed, are the project's coordination, its duration by 4 months, its budget and the delivery dates for its milestones and deliverables.

The project's visual identity was unveiled, consisting of a logo, letterheads, a PPT template, a deliverables template, and an agenda template. The project participants were shown the project website in its first layout that will serve as a vital information hub for information on the EU4Health programme, joint action's materials, presentations and deliverables.

Finally a training program including online and in-person meetings to improve the technical and interpersonal abilities of NFPs and potential stakeholders was introduced.

WP 3: EVALUATION

Project deviation can be a pretty common issue, and this can be even more frequent issue in large projects. But it does not mean it should be simply accepted as it is. A continuous evaluation and assessment will reveal possible deviations with respect to the original plan which allows us to make decisions and stablish a series of corrective and preventive actions to revert those situations.



We are very enthusiastic about the launching the First KPI Collection Survey, as part of the evaluation implementation, because it will give us an updated vision on how the project is going. The results will be shared with the rest of partners at the end of July, so that way every Work Package will have a common vision on the project's progress.

WP 5: SUPPORT SYNERGIES WITH OTHER HEALTH-RELATED

EU FUNDS/PROGRAMMES

"To help foster sustainable national ecosystems for synergies and to empower NFPs and applicants in creating actions that address European and national health objectives."

WP 5 aims to contribute to strengthening of national networks and knowledge management structures for better utilization of synergies between health-related EU funding at implementation level. Based on mapping of existing interacions between NFPs and on current national strategies we will develop and disseminate a set of recommendations for NFPs. We also aim to create fora for exchange of best practices in series of events and workshop activities.

What do you find the most interesting topic /part of WP? Gaining an overview of this broad scope of programmes can be challenging for individual actors, and bringing synergies depends also on strong interactions at national level. We see the challenge and opportunity in this ecosystem of synergies, and hope to play a part in helping NFPs to navigate it. What are the biggest challenges for your WP in next period of time?


A challenge for the work package lies in the fact that strategies to enhance synergies at implementation level remain a strictly national purview, and cannot be directly influenced by the WP5 team through the Joint

Action. We hope to provide support to NFPs to enhance interactions

with other programmes at national level.

What WP "news" would you like to share with us?

We are happy to share that the 'Survey to assess national networks' was recently launched to all participating NFPs, and marks the start of assessment activities. The survey will collect information on the interactions between EU4Health NFPs and their counterparts of other relevant EU funds and programmes, and will be analysed in order to identify emerging strengths, weaknesses, threats and opportunities.

WP 6: CAPACITY BUILDING FOR NATIONAL FOCAL POINTS

With the aim to support equal opportunities to access to the EU4Health Programme for all Member States, WP6 will reinforce knowledge and skills of NFPs, with a view to synergies offered by other EU health-related instruments. Activities include training and twinning programs, the creation of an interactive platform to share good practices and tools between NFPs, the implementation of cocreation labs to support pilot projects on mixed funds.


What do you find the most interesting topic /part of WP?

Working both on technical and soft skills. What are the biggest challenges for your WP in next period of time?


Enabling a sustainable mutual learning experience among NFPs and stakeholders.
