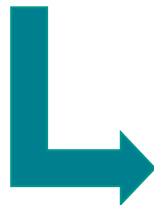
Health Professionals' and the “DigitAl team” Skills advancement - H-PASS

Measures to facilitate the digital transformation of healthcare systems

- Standards for quality assurance and capacity building
- Assessment of the status of demand and supply of health workforce capacity in view of related recovery and resilience plans, reforms and investments
- Benchmarking and review of actions based on state-of-the-art mapping of digital skills training, governance, policies and legislation
- Piloting and planning of actions
- **Establishing coordination mechanisms for synergies with other EU funding instruments and national programmes**
- Establishing e-Government Tools
