What will the Marketplace Section include:



TRAINING

The **Training Section** is dedicated to the EU4Health Training online and onsite (Mod. 1 and Mod. 2) as part of the WP6's activities. Ideally this section could also welcome the possibility to follow other congruent initiatives that NFPs are organizing at the national level. This section in particular is aiming at providing a digital and useful repository containing all relevant follow-up materials: power point









presentations, agendas, and other documents. This dedicated part on the platform will also become a practical calendar listing all the training appointments. As known, the WP6 Training targeting the NFPs, is one of the key project's activities, providing a well-established programme and contributing to the NFPs capacity building.

Important: The Training Session intends to also become an opportunity to share and follow congruent initiatives at the national level (promotion of DG SANTE Annual Work Programmes with national/regional programmes and services. Etc).

AGORÀ



Agorà is a section aiming at providing a live interaction among NFPs. The concept is to have the possibility to use a live chat in order to boost communication and strengthening the NFPs network.

Users will be able to submit topics, comment under posts, and get notifications when participating.

EU PROJECT Database



The ProMIS Database, available at the following LINK intends to become (a non-exhaustive) collection of projects — in the health, research and innovation field — of different stakeholders from different Member States, co-funded by direct funds from the European Commission within the 2021-2027 programming period.

The Database system allows to directly fill-in online surveys in order to collect key





information (ENG). Therefore, it enables an identification of European projects funded in the field of public health as well as allowing to develop targeted statistical studies (excellence, products, economies, resources etc.) thus supporting the process of identifying transferable practices, activated/activatable synergies as well as the planning/design process of vertical and/or system initiatives.
